CONTRACT OPTION 1

☐ FLUCTUATING MARKET PRICE WITH EXTRA DISCOUNT #2 Fuel or Kerosene

A credit balance paid on your account in advance entitles you to a discount of 15¢ per gallon off the daily posted price. No fixed price, no capped price, no fees – just fluctuate with the daily price. Payment due with signed contract.

Example: If daily posted price=\$5.00/gal, cash price with usual 10¢ discount=\$4.90/gal, YOUR PRICE with 15¢ discount=\$4.85/gal.

It is recommended that you start with a **full tank** of oil; otherwise, payment of a delivery prior to 10/1/26 may be necessary. Both contract and automatic delivery will be canceled if payments are not received according to schedule. Budget plans end **5/31/2027**. End of budget deliveries must be paid in full within 30 days of delivery date.

CONTRACT TERMS

- ◆ GALLONS AVAILABLE AT PRICE LEVEL OFFERED ARE LIMITED. SUBSEQUENT OFFERED PRICES MAY BE HIGHER OR LOWER. CUSTOMERS WHO COMMIT TO A CONTRACT WILL BE BOUND TO IT, REGARDLESS OF SUBSEQUENT OFFERS.
- ◆ To participate in our contract plans, customers must have a ZERO balance or a credit balance.
- ◆ Senior citizen discounts will be honored on all contract plans. No other discounts are applicable.
- ◆ **Contract Period: Plans quoted will be valid from October 1, 2026 to April 30, 2027**, or until your prepaid lump sum credit balance or budget gallons are depleted, whichever comes first. Any deliveries made outside of the contract period will be at the daily posted price.
- ◆ **If your account is charged for anything other than oil (for example: service, parts, labor, etc.), payment is due upon receipt of invoice to avoid transfer of prepaid oil funds that will NOT be reinstated.**
- ◆ **If you choose automatic delivery**, you will remain on automatic delivery, even if contracted gallons are exhausted or the contract period ends. You must notify us in writing after your contract ends if you wish to be removed from automatic delivery. Refusal of delivery will incur a \$65.00 fee.
Automatic delivery status is contingent upon meeting current payment terms and may be suspended on any accounts in arrears.
- ◆ Taxes if applicable are in addition to the contract price.
- ◆ This contract may be canceled by a customer who relocates outside of our delivery area and provides a written request for a refund of remaining credit balance to their new address.
- ◆ Orange Oil Company reserves the right to cancel this contract at any time. If Orange Oil Company is prevented or delayed in the performance of this agreement for any reason beyond the control of Orange Oil Company, including but not limited to, acts of God, war, civil disobedience, government restrictions, strikes or labor disputes, curtailments or shortages of labor or supplies including the refusal or inability of Orange Oil Company's suppliers to honor their contracts with Orange Oil Company, Orange Oil Company shall not be liable for actual or consequential damages resulting from the cancellation of this agreement for reasons beyond its immediate control. If such conditions exist, Orange Oil Company shall notify you as soon as practically possible.
